Minutes of last meeting were read by all. Motion made by Wayne Martin to accept minutes as read, seconded by Lynn Logan, all agreed and the motion carried.

New Buiness:

- Bridge lessons were discussed by guest, Kurt Shook. Easy bridge starts in September and runs for 6 months. Classes are for 20 minutes and then play for 2 hours. Bridge college follows in the winter months. Janelle Kunellis also teaches "easy bridge" in Diamondhead. Lynne Logan suggested having additional bridge lessons. Two types of bridge lessons: Easy bridge and Audrey Grant Series. Lynne Logan suggested Janet Signor and herself to teach the classes on Thursdays before the regular bridge games. Joyce Dozier made a motion for additional series of bridge lessons to start in September on Thursday mornings. Seconded by Anne Mahaffey, all in favor and the motion carried. Financial report was read by treasurer, Lynne Logan. Motion to accept report as read by Jerry Grissom, seconded by Wayne Martin, all agreed and the motion carried.

Betty Allen has resigned from the board for personal reasons. Motion made by Dick Weaver to accept Betty Allen's resignation, seconded by Wayne Martin, all agreed and the motion carried.

Old Business:

- Dishwasher issue is tabled for now.
- Backsplash can be struck on the wall. Cost approximately \$30. Wayne Martin made a motion to allow \$50 to purchase the backsplash, seconded by Anne Mahaffey, all agreed and the motion carried.
- Water bills: Lynne Logan made a motion not to be concerned about water expenses. Any changes would need a different meter and less flow. All agreed to leave water meter/issues as they are now.
- Electrical bill for outside light has increased from \$30 to \$62. Lynne Logan made a motion that the light be removed as it is not needed, seconded by Jerry Grissom, all agreed and the motion carried.

New Business:

- Easement: Wayne Martin made a motion to sell easement for \$9442+ expenses, seconded by Lynne Logan, all agreed and the motion carried. Wayne Martin will handle the sale.
- Future tournaments: It was decided to table for now.
- Safety issues was discussed by Jerri Grissom, suggested railings by the front door. Lynne Logan will research and report at next meeting.

Joyce Dozier motioned to adjourn, seconded by Wayne Martin, all agreed and the meeting adjourned at 6:00pm.
